## ORDINANCE AMENDING THE ELECTRICAL PERMIT FEE SCHEDULE

WHEREAS, KRS 227.480(1)(a) requires each local government enforcing the Uniform State Building Code to issue an electrical permit prior to commencing construction, alteration, or repairs to any electrical system; and

WHEREAS, KRS 227.480(3) states that local government may by ordinance fix reasonable fees and establish other requirements for the conduct of electrical inspections within its boundaries; and

WHEREAS, the Warren Fiscal Court has not revised the Electrical Permit fees since

June 2018 by Ordinance 18-31 WC, and it is in the best interest and general welfare of Warren

County to revise its electrical permit fees.

## NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE FISCAL COURT OF WARREN COUNTY, COMMONWEALTH OF KENTUCKY as follows:

- A. Electrical permits shall be obtained for the installation and removal of electrical conductors, equipment, and raceways; signaling and communication conductors, equipment, and raceways; and optical fiber cables as specified in Section 90.2 of the National Electrical Code.
- B. Permit fees for new residential services shall be calculated by multiplying the total building area under construction by \$0.10 per square foot.

- C. Permit fees for new commercial and industrial services shall be as follows:
  - a. 60-125 AMP \$100.00
  - b. 150-225 AMP \$120.00
  - c. 250-400 AMP \$150.00
  - d. Over 400 AMP Two (2) percent of electrical contract including labor and materials for the first \$100,000 and the remaining amount at one (1) percent, or \$0.25 per amp on main service, whichever is greater.
- D. Exceptions to the above fee schedules shall include, but not be limited to, meter poles, reinspection fees, change of service, service repair, or panel changes which shall be charged a flat fee of \$50.00.
- E. Plan review fees shall be charged a flat fee of \$100.00.
- F. A maximum fine of \$500.00 will be charged to any permit applicant that begins work without first receiving a permit.
- G. A fine of \$100.00 will be charged to any permit applicant that fails to request for inspection of any required inspections applicable to the permit.
- H. This Ordinance hereby replaces and repeals Ordinance 18-31 WC; and,
- I. The provisions of this Ordinance are hereby declared to be severable, and if any section, phrase, or provision shall for any reason by declared invalid, such declaration of invalidity shall not affect the validity of the remainder of the Ordinance; and,
